A Letter from the Co-Presidents

Happy New Year! Wishing you all the best for a promising 2023. We had a wonderful holiday gathering at Sarah's home sharing good conversation with long-time and new members. Thanks to the Board for providing a delicious spread of food for all to dine on!



A New Member Orientation took place at the beginning of the event. Many thanks to Judy Gervase for leading a great review of what the League is all about with 5 new members. The turnout for our fundraising event at 10,000 Villages resulted in a donation to LWVGE in the amount of almost \$600.

On December 7, a Vigil was held in front of the DuPage County Courthouse to bring attention to the Moore v Harper case being heard before the US Supreme Court; a case referred to as the independent legislative theory. Speakers included Sania Irwin, Jackson Paller of Citizen Advocacy Center, Donna Limper of RepresentUs and Jay Young of Common Cause. Connell Tavis also played a trumpet solo of God Bless America and Kaley Mockus sang "This Land is Your Land." Both the Daily Herald and Chicago Tribune gave advance publicity to the event.

An All (DuPage) Leagues meeting was held on January 16 at the Wilder Mansion. All 7 sister Leagues were represented and great learning sessions were held for Voter Services, Programs, Advocacy, Treasurer, Environment, Communications, League Presidents and Vice Presidents, and Membership.

A recount for DuPage County Board District 2 and State Representative District 45 began with a discovery recount on December 20. **Thanks to Voter Services Co-Chair, Erica Nelson for observing this process, representing LWVGE.** The sampling of ballots will provide information for a possible full recount.

We are thrilled that the Charlotte Swett Walter (CSW) Democracy Challenge program kicked off this month. You can read more below about this exciting program being offered to our two Glen Ellyn High Schools. Thanks go to Social Studies Chairs Rueben Rodriguez, GBS and Kristen Brandt, GBW for working with the CSW committee to tailor the award program for our schools. Thanks to the CSW committee Karin Daly, Judy Kinn and Karen Schulz for joining your Co-presidents with thoughtful planning and execution of this program. Extra kudos goes to Karin for her organizational skills and the beautiful graphics for the posters and flyers.

National and Illinois League News

League Advocacy Never Ceases

For all our members, but especially those new to League, it is important to know our history for advocacy is always on-going. Based on study, consensus and Position development, LWVGE, along with the State and National Leagues, make determinations on issues that need our advocacy as well as demand our action. These issues are not "one and done" but rather, require continuous stewardship and advocacy by League over years and even decades.

For example, on Dec 7, 2022, several DuPage area Leagues held a vigil in front of the DuPage County Courthouse to bring attention to the Moore v Harper case being heard before the US Supreme Court that day. (National LWVUS rallied on the Supreme Court steps). The case

centers on maintaining oversight by state judiciaries over voting laws and rights in individual states- in this case Georgia. Voter rights is the heart of the LWV's mission. LWVGE held a similar type Vigil in front of the Glen Ellyn Village Hall Jan 6, 2022 to mark the one year anniversary of the attack on the US Capital. Defending Democracy is also the heart of the LWV's mission.

More recently, Illinois passed a ban on assault-type weapons. LWVIL advocates restricting access to automatic and semi-automatic assault type weapons by private individuals and a similar position exists at the National LWV level. On January 13, 2023, DuPage County Sheriff Mendrick issued a statement with his position to not enforce the new Illinois law. The League of Women Voters supports the new legislation that caps the sale of high-capacity assault type weapons and ammunition magazines for the well-being of our community and are asking Sheriff Mendrick to respond to the wishes of DuPage County voters by complying with the new Illinois assault weapons and high-capacity magazines law. The seven DuPage sister Leagues are writing a letter to the editor stating the league's position and support for enforcement of Illinois law.

Some advocacy is immediate with a quick response. Other times, it is longstanding with slow progress like the issue of increased Affordable Housing in Glen Ellyn. The glacial pace for change can be challenging, and the list of issues is long! League is forever advocating for voter education and access, for informed and active citizen participation in government, for influencing public policy through education and advocacy, protecting the environment, fair education, DEI...and many more. It can feel overwhelming at times to work alone, but it can feel energizing to work with other members on an issue that interests YOU. That is why we want to encourage you to GET INVOLVED... find your League niche. Your ADVOCACY interest. Please email either of us to set a time to discuss where your special skills and talents can best be shared or contact anyone on the Board listed in your membership book. Your energy, enthusiasm and new ideas are needed!

2022 General Election Recap

Election turnout in the area was a little shy of the turnout for the previous mid-terms in 2018.

DuPage County turnout was 56% of registered voters (343,734 ballots cast by 616,281 registered voters). This compares to 58% turnout for the 2018 mid-terms when 369,940 ballots were cast. About 21% of 2022 general election ballots were cast by mail, 25% were cast during early voting and, the balance, 54%, were cast on election day.

Locally, Illinois House District 42 (representing most of Glen Ellyn, Lombard and, Lisle) saw 60% turnout. This compares to 62% turnout for the old IL 48 in 2018 (Illinois districts were re-numbered after the 2020 census).



2023 General Election

The 2023 Consolidated General Election is set for April 4, 2023. Board member elections will be held for Glen Ellyn School District 41, Community Consolidated School District 89, Glenbard Township High School District 87, Village of Glen Ellyn Trustees, Village of Glen Ellyn Library Trustees, and Glen Ellyn Park District Board Commissioners.

LWVGE is planning to hold candidate forums for these offices on Saturday, March 4, 2023 at

Hadley Jr. HS. We will need many volunteers to help run this important event! Please email voterservices.lwvge@gmail.com if you want to volunteer.

Turnout for these Consolidated elections are typically abysmal compared to mid-terms and presidential elections! The 2021 Village of Glen Ellyn turnout was about 25% while county-wide turnout was about 17%. Any suggestions to improve on this paltry level of participation would be welcome.



Voter Outreach

A small team of League volunteers visited WDSRA's Rec and Roll program at Ackerman Sports Center on December 8, 2022. Rec and Roll is a social and recreational day program for adults with intellectual disabilities aged 22 to 55. We talked about voting and ran a mock election. The mock election results concluded that pizza was the preferred lunch entrée, while chocolate narrowly edged out vanilla in a run-off as the preferred ice cream flavor. We're planning to return in February at lunch time to make good on our election promises.

LWVGE Community Issues

GE League's Strong Affordable Housing Advocacy Continues!



Members of our League, joined with DuPage United (a coalition of local churches), to show our strong support for a proposal from non-profit developer "Full Circle Communities". They would build affordable, accessible and supportive housing on the Village's Roosevelt and Taft properties. We joined with at least 100 others in favor, resulting in an overflow crowd at the Village's January 9th Board Meeting.

Julie Evans, a GE resident since 1994, as well as a League member, was chosen spokesperson

for DuPage United, its Allies and for residents with developments and intellectual disabilities. She spoke of the urgency of making a decision based on a funding deadline and urged the Trustees "to work together to create a living community that is welcoming, offering safe, attractive and an affordable environment for all residents." Hear her powerful statement in full by viewing this link from meeting (beginning at the 33:00 minute mark)

This is only the latest in League's ongoing efforts to educate Glen Ellyn on our position regarding the need for "deliberate planning that can result in housing that appeals to and is affordable for people with a wide range of incomes and lifestyles, promoting a vibrant, welcoming community".

Our Village owns this property, and therefore has the ability to choose a proposal that can serve those residents most in need. This is not the case with for-profit developers who continue to build developments based on profit that provide only luxury rentals.

Our League has been successful in its advocacy to include 2 affordable housing units in the Glenwood Station Development on the former McChesney and Miller property. We know, however, that the need is so much greater especially for residents on fixed incomes, local workers in the retail and service sectors as well as for young families and for recent graduates returning home to join the workforce. That's why new affordable projects like the one proposed are so very important!!

A vibrant community "makes room" in its housing supply for these varied and important populations. We indeed "Need The People Who Need Affordable Housing"!!

We came, we saw, we counted!

Continuing the participation of past years, the LWVGE again tabulated the ballots from the election for Village Trustees and Library Board trustees held at the Civic Betterment Party's Town meeting on December 3rd. This election was to choose the slate of candidates that would appear on the ballot in the consolidated election on April 4, 2023.

The CBP called to order the Town Meeting at 10:00am. There were 82 people present. Part of the agenda allowed each of the candidates to present themselves as well as open nominations from the floor. Then the meeting was suspended until the vote counting was completed.

While voting was open from 9:00am-2:00pm, we began tabulating at 1:00 pm so that we could finish quickly. After the voting closed at 2:00pm, the remaining and Drive Thru ballots were delivered to us. The tabulating was completed, without a recount, at 3:00pm. Both the CBP and the candidates were thankful for our quick and efficient work so that they could announce the results and adjourn the meeting.

A total of 575 ballots, or affidavits, were counted, with nearly 49% of the votes cast at the meeting itself, 18% from Early Voting and 33% from the Drive-Thru voting at the Library.

The Village Trustees that advanced to appear on the April 4, 2023 ballot include: **Donna Jean Simon** (324); Kelli Christiansen (283) and **Steve Thompson** (268). The Library Trustees that advanced to appear on the April 4, 2023 ballot include: **Mary Sue Brown** (367); Karen Volk (363); **Kathy Slovick** (325) and Richard Jones (257). **Four of the seven candidates are LWVGE members (names in bold)!**

We were gratified that many of the recommendations documented in the League's CBP study and presented to the Civic Betterment Party were already implemented, including

Early Voting, Drive Thru Voting and improvements to the CBP website. We were told additional recommendations will be adopted in the future.

Josh Cattero, CBP President, on behalf of the CBP committee, thanked the League of Women Voters for their help and hard work today and input through this cycle.


Legislative Issues
