# League Issues

**LWVIL ISSUES BRIEFING 2021.** The League of Women Voters of Illinois holds an Issues Briefing annually in February or March. It is normally an all-day event, but this year it was held virtually on two Saturday mornings in February. Three topics relating to positions of the State League were presented by an expert panel each week. The topics presented were:

- Restoring Environmental Stewardship and the Pursuit of Ecojustice
- After the Graduated Rate Income Tax Campaign: Now What?
- Housing is Everything: The Role of Housing as a Determinant of Economic Success
- Recognizing and Doing Something About Systemic Racism and Inequality
- Welcoming City, Sanctuary City
- Redistricting in 2021: Community Mapping

#### **Legislative Interviews Continue Virtually**

The LWV annual Legislative Interviews have begun, albeit differently this year. Instead of the traditional face to face interviews that local Leagues hold each spring, this year they will be done virtually.

On March 15 we partnered with two other Leagues, Wheaton and Downers Grove-WoodridgeLisle on a Zoom meeting with District 48 Representative Terra Costa Howard. Here's a summary of what we discussed.

Legislating during a pandemic was mostly virtual and lacked the usual spontaneous negotiations that are an important part of bill making. Six to seven virtual committee meetings per day is common. The three primary focuses of our conversation this year were: funding education, redistricting and environmental legislation. Other topics we covered were: her vote on

the criminal justice omnibus bill and the Governor's budget. In determining her vote on an education bill, or any bill, the representative will always consider how it affects her district, including taxes for constituents. She does not support the "Invest in Kids" initiative, a tax credit scholarship program, as it would take money away from public schools in DuPage County. Representative Costa Howard was the lead sponsor of the Fair Maps Bill that ultimately did not get voted on in 2020 because the COVID pandemic drastically interrupted and shortened the legislative session. The legislature will begin working on the 2021 redistricting plan soon, with a virtual, town hall meeting in DuPage County April 2. She stressed that voters need to understand that you can't tell whether a map is fair just by looking at the district shapes. What's important is making sure that communities aren't split across districts for partisan reasons.

Citizens of DuPage County and D48 are supportive of environmentally related legislation. Representative Costa Howard will support the Clean Energy Jobs Act (CEJA) and believes it will gain bi-partisan support. The representative did not vote for the Criminal Justice Reform omnibus bill. She explained that voting for an omnibus bill, which includes many diverse issues, requires an "all in" or "all out" vote. She supported some issues included in the bill, but not all. In addition, voting against it seemed to be important to her constituents as witnessed by the overwhelming number of calls she received opposing the bill, while there were no calls in support of it.

Representative Costa Howard is in favor of decoupling the Illinois tax structure from the federal structure as it applies to the COVID relief 2020 CARES Act. Under the current structure, certain large companies in Illinois would be able to claim losses against gains going back five years. Decoupling would remove that provision, allowing the same companies to still deduct losses going forward one year. Without decoupling, Illinois could lose \$500m to \$1.8b in revenue. This is something the governor also supports.

Contact the representative at **REPTCH48@gmail.com** to let her know if you support or oppose any of these issues. Constituent opinion is important to her. We continue to push for a meeting with D 46 Representative Deb Conroy and our two state senators, Suzy Glowiak Hilton and Thomas Cullerton.

## League Comms: Getting the Word Out In A Changing World

Your League Communications team has had quite a year. With the pandemic turning everything "virtual" in the midst of our 100th year of the League and women's suffrage, we have had to up our game! The team's work runs the gamut: From managing the website, putting out *The Voter*, creating and posting on social media, sending meeting reminder postcards and emails, creating the membership directory and making sure all the League news and events get published in local media and community venues.

The Communication's team has two key target audiences: Our League members and our community, with some overlap. And everyone likes to be communicated to in a different way so that creates a challenge. This year, we branched out into new areas during the 2020 election, such as suffragette scarecrows and storefronts, voter postcards, lawn signs, Voting FAQ flyers and posters and targeted communication to houses of worship, working closely with the voter services team. Voters were motivated to turn out and be involved, and we hope we did our part to encourage the historic voting levels with our strong visibility and prominent "Don't Just Vent, Vote" messaging. Our website attracted over 12,000 unique visitors in 2020, with 4,000 visiting in October, both record highs.

The April election has been a different challenge given historic voter apathy for off-year municipal elections, so we leveraged a "Be Vocal, Vote Local" effort to try to encourage participation. We kept our website always up to date so that League members and the community always knew the latest information.

Let's celebrate all the work of the Comms team, keeping us informed! And there is always more

to be done. If you are interested in helping, please reach out and let us know!



# February Book Club Inspires Essay




After our LWVGE discussion of the book *Garbology* a few League members asked me to explain a little more about my perspectives surrounding garbage. So, I wondered, where did my garbage-obsessed life come from? It might have started in Guatemala where I lived with a group of fellow students working in the small, rural village in the mountains near Conacaste. As we lived and worked there building a school, we began to notice that the villagers were very interested in our American garbage. As we finished with plastic sheeting, one family took it home and made a roof. As we emptied a large shampoo bottle, a local woman asked to have it so she could have a container reliable enough to hold water and carry it home from the village well.

Or maybe my obsession started when I was in Georgia working for Habitat for Humanity. A group of us went out to work on what appeared to be an abandoned house, surrounded by trash in a remote woodland setting, where if you looked very closely through the trees, a woman could be seen on her porch with her open-lidded washing machine running next to her. As we left after a full day of work on her property, our mentor explained that this woman, Mary, was considered well off in the local community. Her garbage was evidence of her ability to consume, and no one was allowed to tidy her property ever. When asked about the curious use and location of the washing machine, I learned that this was the ultimate in status. Mary was proving she could afford both electricity and a working washing machine, which was extremely rare. Any other washing machines we spotted in the nearby yards didn't work. They were simply an attempt at collecting a very curious local status symbol. When the book Material World was published in 1994 I was connected back to these moments from my own life and saw them expanded to homes and people from all over the world. This book isn't about garbage exactly, but it seems to indicate something about the future garbage humanity will be facing. This idea of "future garbage" leads to thoughts on a final book I will mention, Secondhand, which was recommended to me by our own LWVGE expert on recycling, garbage, and minimizing your impact on the planet, Eileen McArdle. This book is about tracking our donations, usable discards and garage sale items around the planet to see where they end up and who wants them. The results are surprising. Who wants my broken TV? Evidently many people do. It's just a matter of getting it to them. This book is about how that happens.

When analyzing my personal garbage issues, it is easy to blame my mother (Freud would) but now that I am a mother, I try not to go there too often. After reading <u>Garbology</u> and these other books, and discussing them with League friends, my mother would say we have to find ways to do better. She

would say, don't buy it in the first place unless absolutely necessary, and even then, think twice about the garbage trail this item has left in its wake of production and will leave forever into the future, leaving this teacher with the perpetual question; "Does that really need to be laminated?"
