National Voter Registration day at COD on September 28 saw members Bonnie Wheatley, Carrie Burrows, Donna Jean Simon and Mary Sue Brown on hand to register local students. LWVGE was also present that day at the Glen Ellyn Public Library, where smiling members Jean Tufano and Judy Gervase posed, and enrolled new voters. The LWVGE, along with our DuPage sister Leagues (Wheaton, Naperville, Downers Grove, Lisle/Woodridge, Roselle/Bloomingdale, Elmhurst, and Aurora) have continued to closely monitor DuPage County Board meetings. Two County agenda items and a court-ordered partial recount kept us busy.

Purchase of secure voting equipment: Thank you to members for connecting with County Board members (as constituents) prior to the September 14 County Board Meeting in support of the purchase of new secure voting equipment. Although the approval by the County Board failed, the LWV continued voicing the urgency to purchase new equipment in a timely manner and, after a quick rebidding process, on October 25, the County Board approved the purchase of new secure voting equipment (Hart System) for DuPage County that meets the requirements set forth in HR1.

Revisions to County District Maps: In August, the public comment period began on the redrawing of the DuPage County District Maps. Thanks to DuPage County Board Observer Dave Evans for observing the first Open House to learn what the upcoming process would be. Mid-October, the redrawn District Maps, based upon data from the 2020 Census, were on display both on the County website and in the County Board Room for a three-day Open House. Thanks to Karin Daly for getting this information out quickly to members. The LWVGE and DuPage Sister Leagues were represented at the Open House and at the October 26 County Board meeting to support the approval of the new District Maps. The County Board voted to approve the re-drawn DuPage County District Maps; many DuPage County Board members thanked the LWV for monitoring the process.

Partial Recount from November 2020 election: After a DuPage County court review of a sample of ballots for the November 2020 DuPage County Auditor election, the judge ordered a partial recount. This included (1) a review of Election Day in-person ballots to verify election judge initials were placed on the ballots and (2) a review of mail-in ballot envelopes to verify postmark dates and voter signatures. A number of LWVGE members trained and received credentials as Pollwatchers and prepared for observation during an anticipated three-week process. The partial recount began on October 4 and ended on October 6 due to the efficiency of the Election Division staff and election judges. attorneys and Election Division staff met on October 8, with LWVGE & DuPage sister Leagues observing, to review the results. A report will be prepared for the judge to review at a hearing scheduled for November 8. The LWVGE will continue to monitor this activity to verify that the process is transparent and to make sure every vote counts.



Environmental Update

LWVGE is a member of two inter-league environmentally focused organizations, the LWV Upper Mississippi River Region (LWVUMRR) and the LWV Lake Michigan Region (LWVLMR). Each of these interleague organizations was established to address issues best understood on a regional level and that transcend political boundaries. This is especially true for water issues. Each October these two groups conduct their annual programs and meetings.



LWV Upper Mississippi River Region, October 4

This year the LWVUMRR focused on PFAS with a presentation on "Should You Drink That? The Unfolding Story of PFAS in Our Lives". Speakers included Jeff Lamont, retired hydrogeologist who works with SOH20 (Save Our H20) to ensure safe drinking water for residents in Northern Wisconsin; Erika Schreder, Science Director Toxic-Free Future who writes on toxic chemicals and their presence in people and products and alternatives; and Deanna White, MN Director, Clean Water Action, who coordinates EPA and state interactions for policy and legislation.

References and concern for PFAS or "Perfuoroalkyl & Polyflouroalkyl compounds" has recently been elevated by many organizations and has become a priority for the Biden administration under the direction of Michael Ragan, EPA Administrator. PFAS refers to more than 4000 man-made chemicals that are often called "forever chemicals" because they do not break down in the environment. Exposure to these PFAS chemicals has been linked to certain cancers and has been devastating to many communities across the USA for decades. PFAS chemicals have become ubiquitous in consumer products because they are resistant to heat, stains, water, and grease. Efforts are underway to get PFAS out of the marketplace and replace with safer alternatives. There is focus on removing these chemicals from cosmetics, carpets, spray treatments, kids' products, food packaging and fire fighter gear and equipment.

Water sources have and continue to be contaminated by PFAS chemicals. While efforts are underway to restrict PFAS in drinking water to not exceed 70 parts per million, there is

no enforcement and some environmentalists believe there are no safe levels. There is debate and conflicting opinions as to what methods might be useful in the disposal of PFAS.

Incineration is one solution under consideration but remains controversial. In August Governor Pritzker vetoed a bill meant to prevent the incineration of PFAS saying the bill was overly broad and would unintentionally prohibit companies from using other types of pollution control devices. Pritzker did however sign SB561 that phases out the use of PFAS in firefighting foam. There were also concerns regarding the environmental justice impact on communities that house the incinerators; poorer communities being subject to the unknown impact of releasing incinerated chemicals into the environment.

President Biden has called for \$10 Billion in funding to address PFAS contamination. What actions can individuals take:

- Educate yourself on PFAS science
- Encourage your favorite fast-food venues, grocery stores, cosmetic lines to stop using PFAS by letter writing campaigns. (Latest is to Burger King.) This is a bipartisan issue that impacts everyone and is a unifying issue
- Write state and national representatives to ban PFAS.

<u>LWV Lake Michigan Region Meeting and Conference October 15-16</u>

The focus of this year's conference was Lake Michigan shoreline erosion and pollution. Featured speakers were Joe Gruzalski, Indiana Dune National Park Ranger, on "Bad Ass Women of the Dunes"; Erin Argyilan, Professor of Geosciences & Dept. Chair Indiana University Northwest on "Shoreline Erosion and Solutions;" and Dr. Victoria Wittig, Senior Program Specialist, Save the Dunes on "Lake Michigan Pollution and Solutions."

The Dune Park Ranger highlighted the history of many forgotten women who fought to save the Indiana Dunes, biologists, activists, geologists, and amateur naturalists. There is actually a guided park tour that folks can take that explores, hikes, and discusses places in or near the park that shaped many of these influential women.

The Indiana Dunes have been in the news as of late due to the collapse of dunes, the disappearance of shoreline and park closures to pollution. Dr. Argyilan provided a detailed crash course in the impact of geologic history and climate change and how these are impacting the erosion and rebuilding of the sandy Lake Michigan shoreline. In some communities the shoreline is disappearing only to have eroded sand and soil to be deposited on another community along the shoreline. This evolution of the shoreline is both the result of historical trends as well as climate change. Communities negatively impacted have taken steps to save their shorelines that may actually be detrimental to other communities along the shoreline and extremely expensive. The recommendation is for communities to work together and have a better understanding of historical trends and climate change impacts

Dr. Wittig addressed the impact of both agricultural, pharmaceutical, construction waste, and even domestic waste on Lake Michigan. Advocacy efforts and initiatives are both listed on the LWVLMR website. The LWVLMR is sponsoring a Climate Change Symposium hosted by Tom Skilling in April, 2022 in Chicago. Details will be forthcoming.
